Maggie Timoney is the President & CEO of HEINEKEN USA based in White Plains, New York. During her 20+ year tenure with the HEINEKEN Group in the US, Netherlands, Canada and Ireland, Maggie has been recognized for being a transformational leader as demonstrated through her results at a P&L level combined with a high impact in both cultural and social change. Prior to joining HEINEKEN, she worked for Gallo and Anheuser-Busch. Throughout her career, Maggie continues to blaze the trail as a senior female executive in a traditionally male-dominated industry. Today, she is the first woman to serve as chief executive of a major beer company in the US.

She often credits her time spent on the court in helping shape her leadership skills. This year, our St. Patrick Award for Community Service will be presented to Rabbi Joseph Potasnik, Executive Vice President of the New York Board of Rabbis, for his extraordinary lifelong service to our city and for promoting understanding across all faiths. He serves as chaplain for both the FDNY and the Fraternal Order of Police. He also serves on the board of The Archbishop Fulton Sheen center.

Our Mission and Our History

The mission of the St. Patrick's Day Foundation is to support the New York St. Patrick's Day Parade, and celebrate the contributions of the Irish to American society, with scholarships and an ambitious year-round program of social and culture events. The first New York St. Patrick's parade stepped off Lower Broadway on March 17th 1762, fourteen years before the Declaration of Independence. Over two hundred and sixty years later, it is considered the largest parade in the world, with two hundred thousand marchers, and more than two million spectators lining Fifth Avenue. The television broadcast of the parade connects over 1.5 million household viewers with this extraordinary tradition, and the web-streaming of the parade, which began in 2008, expands the impact of the parade worldwide.
